SUPPORTING MEMBERS IN TIMES OF COVID-19

2021 was a year dominated by the COVID-19 pandemic. The COS team continued to provide the high-quality educational content that members have come to expect and shifted some of our offerings to include a focus on wellness. A few initiatives are described on the following page.



FOCUS ON WELLNESS

In addition to providing workshops on mindfulness and how to deal with complaints, COS organized a webinar in early January titled “Leading from Languishing to Thriving” in which keynote speaker Dr. Susan Biali Haas guided participants through an exploration of stress management, burnout prevention, and human resilience in the context of living through the COVID-19 pandemic. The webinar was highly interactive with many polling questions related to desire to travel, mental health, surgery backlogs, and more.



WEBINAR AND REPORT ON THE IMPACT OF COVID-19 ON THE COST OF VISION LOSS AND BLINDNESS

Special thanks to COS President Dr. Colin Mann for his participation in the October 26, 2021 webinar that presented the findings of the COVID-19 addendum to the *Cost of Vision Loss and Blindness in Canada* report. Spearheaded by the Canadian Council for the Blind and Fighting Blindness Canada, COS and the Canadian Association of Optometrists (CAO) supported this work through a small grant. The report, which highlights the impact of COVID-19 on the vision health community, was released in the fall of 2021. The report estimates that there were 335,000 fewer surgeries of all types between March and June 2020 (a 47% decrease).



PRACTICE RESOURCE CENTRE

The Practice Resource Centre (PRC) received a new look and increased functionality in 2021 and is quickly becoming the “go-to” online resource for ophthalmologists. (Additional information can be found in the Education section of this report.)



ONLINE ANNUAL MEETING AND OTHER EDUCATIONAL CONTENT

The 2021 COS Annual Meeting and Exhibition was moved to a fully virtual event, attracted over 1,000 delegates, and provided high-quality scientific content. (Additional information can be found in the Education section of this report.)

ACCOMPLISHMENTS

ADVOCACY

Advocacy is becoming more relevant to the clinical work of COS members.

While ophthalmologists are busier than ever, it is critical to carve out time to be represented on working groups and in association membership. This is how we will ensure that the important issues being discussed with government keep ophthalmologists and their patients' needs front and centre. As the voice for the profession, COS promotes and supports the values of cost-effective, patient-centred, evidence-based care, and we continue to work with provincial and federal stakeholders on common advocacy goals. 2021 was a year focused on strengthening our foundations in advocacy and paving the road for a clear, targeted, and effective advocacy strategy. We are grateful to our members for supporting all our advocacy efforts, including social media activity, cross-organizational input on advocacy campaigns, and endorsement of policy recommendations to government.



NON-HOSPITAL SURGICAL CENTRES

As the COVID-19 pandemic dragged on, surgeries continued to be delayed or postponed. Some provincial health ministries have responded to the backlog of cataract surgeries with the launch of RFPs for non-hospital surgical centres (NHSC). The response to these centres varies from province to province and within the ophthalmology community in general. COS held a workshop in September with 13 ophthalmologists to identify the risks and benefits of NHSCs and to help elucidate the principles that would help to minimize risks and maximize benefits. A summary report was prepared and a document of principles will be shared with all members in early 2022.

OPTOMETRY SCOPE EXPANSION

COS worked closely with the Eye Physician and Surgeons Association of Alberta (EPSAA) to respond to a proposal for optometric scope expansion in Alberta. COS was successful in delaying the submission date, which allowed us time to build a coalition with EPSAA and provide solid, evidence-based responses to the expansion proposal. The Government of Alberta is currently reviewing the submissions.

There has also been significant activity on this issue in other provinces, notably in New Brunswick and Newfoundland and Labrador.

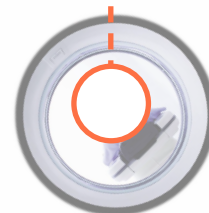
COS acted as a key informant for the Canadian Medical Association (CMA) report titled *Clearing the Backlog: The Cost to Return Wait Times to Pre-Pandemic Levels*, which quantifies the backlog of six surgeries resulting from the first wave of COVID-19. Cataract surgery was highlighted in the document.

COS is working closely with these and several other provincial ophthalmology groups and their advocacy representatives to provide support, resources, and information for their advocacy outreach efforts. All these activities reinforce the need for continued, consistent, and ongoing outreach by ophthalmology associations to their provincial governments.

DRUG SHORTAGES

COS continued to be actively engaged with Health Canada's Tier Assignment Committee (TAC) to represent member and patient interests on ophthalmic drug shortage issues. Separately, COS also tracks ophthalmic drug shortages through multidata input from the Drug Shortages Canada database and our industry partners, who voluntarily share with us anticipated shortages and backlogs. A [list](#) of current and anticipated drug shortages (updated daily) is available to COS members.

COS also worked with the Canadian Retina Society (CRS) to release *Guidelines for Supply Triage During the Visudyne (Vertporfin) Shortage*. These guidelines, which were sent to all COS and CRS members, helped ensure that the remaining supply of Visudyne was used in the most effective way. COS and CRS also worked with Health Canada to attempt to resolve the shortage.

EQUITY, DIVERSITY, AND INCLUSION (EDI) WORKING GROUP

COS convened an EDI Working Group, chaired by Dr. Nupura Bakshi. The group is enthusiastic and has begun discussing projects and initiatives in four main areas of focus: Education, Research, Support/Advocacy, and Improving Diversity in Ophthalmology. GLAUCOMA 2021: BACK TO THE FUTURE

A symposium co-developed by COS and Allergan, an AbbVie company, was delivered by expert Canadian faculty Dr. Delan Jinapriya, Dr. Kaisra Esmail, Dr. Georges Durr, Dr. Priya Gupta, and facilitated by Dr. Ike Ahmed (Chair). Delegates explored cases in glaucoma management that focused on setting intra-ocular pressure targets, monitoring progression, identifying adherence issues, and discussing timing and ordering of surgical strategies.

An on-demand, Section 3-accredited module featuring content from the Glaucoma 2021: Back to the Future symposium is available online. This is a 90-minute module that includes pre- and post-testing, videos, and an evaluation. Visit the [website](#) to participate.

INNOVATION IN RETINA RESEARCH AWARD AND LIONS' LAIR SYMPOSIUM

The Innovation in Retina Research Award was offered by COS with the support of Bayer. Applications were scored based on an independent peer-review process in advance of the 2021 COS Annual Meeting. During the Lions' Lair Symposium, co-developed by COS and Bayer, the top-scoring three finalists "pitched" their research to the conference

audience and judging panel. Three prizes totalling \$75,000 were awarded by the judging panel: Dr. Michael Kapusta (Chair), Dr. David Chow, Dr. Marc Saab, Dr. Amber Sheikh, and Dr. Matthew Tennant. Congratulations to winners: Dr. Fares Antaki, Dr. Austin Pereira, and Dr. Samir Touma. While the judges were deliberating, Dr. Aaron Lee provided an informative keynote lecture on how using digital innovations in ophthalmology can optimize patient care.



52ND SALLY LETSON SYMPOSIUM

The 52nd Sally Letson Symposium, *Focusing In: Ophthalmology and Wellness Practice Pearls*, was held virtually on September 11, 2021, and was attended by 385 delegates. The content-rich, one-day meeting, which was supported by the COS team, was highly successful. In the meeting evaluation, participants expressed their appreciation for how wellness topics were woven into the program amidst the more traditional topics.

TOPICAL ISSUES ON nAMD ADDRESSED BY RETINA EXPERTS

This program, co-developed with Novartis, saw the development of three recorded modules in 2021: 1) Improving the Patient Experience Towards Optimal Outcomes; 2) Preferred Practice Patterns in the Prevention and Management of Complications to Intravitreal Injections; and 3) Analysis of Retinal Fluid with Artificial Intelligence. Thank you to the Scientific Planning Committee for their work on this initiative: Dr. Bernard Hurley (Chair), Dr. Don Nixon, and Dr. Deepa Yoganathan.

COS PRACTICE RESOURCE CENTRE (PRC)

In June 2021, COS launched a new design for the **Practice Resource Centre** making it more user-friendly and appealing. The updates were based on an extensive feedback and evaluation initiative to ensure

that the website continued to provide value to COS members. The COS team continues to work with the website developer to include enhanced features like a member login with members-only content and a personalized reading list, which will be released in 2022.



STANDARDIZED NATIONAL CURRICULUM FOR UNDERGRADUATE MEDICAL EDUCATION (UGME) IN OPHTHALMOLOGY

Dr. Christine Law, Dr. Anu Mishra, and Dr. Nawaaz Nathoo began working to develop a standardized national curriculum for Undergraduate Medical Education (UGME) in ophthalmology.

COS PHYSICIAN WELLNESS INITIATIVES

COS was a recipient of targeted funding from MD Financial Management, Scotiabank, and CMA as part of an Affinity Agreement. This funding (\$200,000 from 2019 to 2021) was directed towards physician wellness initiatives. Thank you to the COS Physician Wellness Steering Committee members Dr. Lisa Gould (Chair), Dr. Lorne Bellan, Dr. Colin Mann, and Dr. Rishi Gupta for their efforts in bringing awareness to wellness and existing supports through this three-year initiative.

2021 programs included:



"Everyday Mindfulness for Busy Clinicians"

Offered in January, February and June, this virtual workshop introduced mindfulness

skills and included guided practice, as well as dyad exercises and group discussion. Forty-six physicians participated in the limited-attendance sessions.



"So You Got a Complaint, Now What?"

This highly successful and informative webinar was held in March, with over 170 attendees. Feedback from the webinar was very positive. A number of attendees noted that they became more aware of the potential psychological impacts of complaints and that the physician is not alone in the complaint process, as support is available.



"Leading from Languishing to Thriving"

This very interactive webinar, held in June, provided participants with an opportunity to hear from their peers across the country regarding ophthalmology's ongoing experience with the COVID-19 pandemic. In addition, Dr. Susan Biali Haas provided a keynote presentation that offered participants specific actions to empower them in their personal and professional lives, as well as to help those around them to thrive.

INHERITED RETINAL DYSTROPHIES (IRDs) NEEDS ASSESSMENT

In partnership with Novartis, COS developed and disseminated a needs assessment survey to members on IRDs. Thank you to the Planning Committee members: Dr. Ian MacDonald (Chair), Dr. Radha Kohly, Dr. Cynthia Qian, and Dr. Johane Robitaille. The needs assessment identified that more than half of patients with suspected IRD are seen by an IRD specialist within six months of referral. Respondent knowledge was particularly low regarding access to gene-therapy and assistance programs, publications, and patient characteristics associated with best gene-therapy outcomes, and clinical trials. However, knowledge with respect to signs and symptoms of IRD was high. The most common challenges associated with both identifying and managing patients with IRD were primarily related to access: genetic testing, electrophysiology/electroretinogram, and IRD specialist/geneticist/genetics clinics. Waiting time was selected most frequently as the most significant barrier to obtaining genetic testing. This needs assessment will be a great asset in CPD planning in the future.

CANADIAN JOURNAL OF OPHTHALMOLOGY (CJO)

CJO achieved a historic milestone in 2021 with an Impact Factor of 1.882 (a 37.5% increase from the previous year) – the highest ever recorded. This milestone is a reflection of Editor-in-Chief Dr. Varun Chaudhary's vision of the CJO as a global leader among ophthalmology journals.

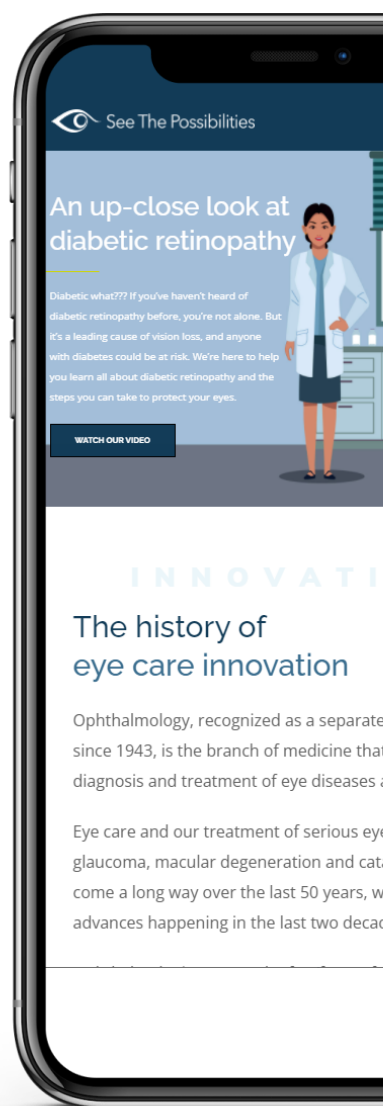

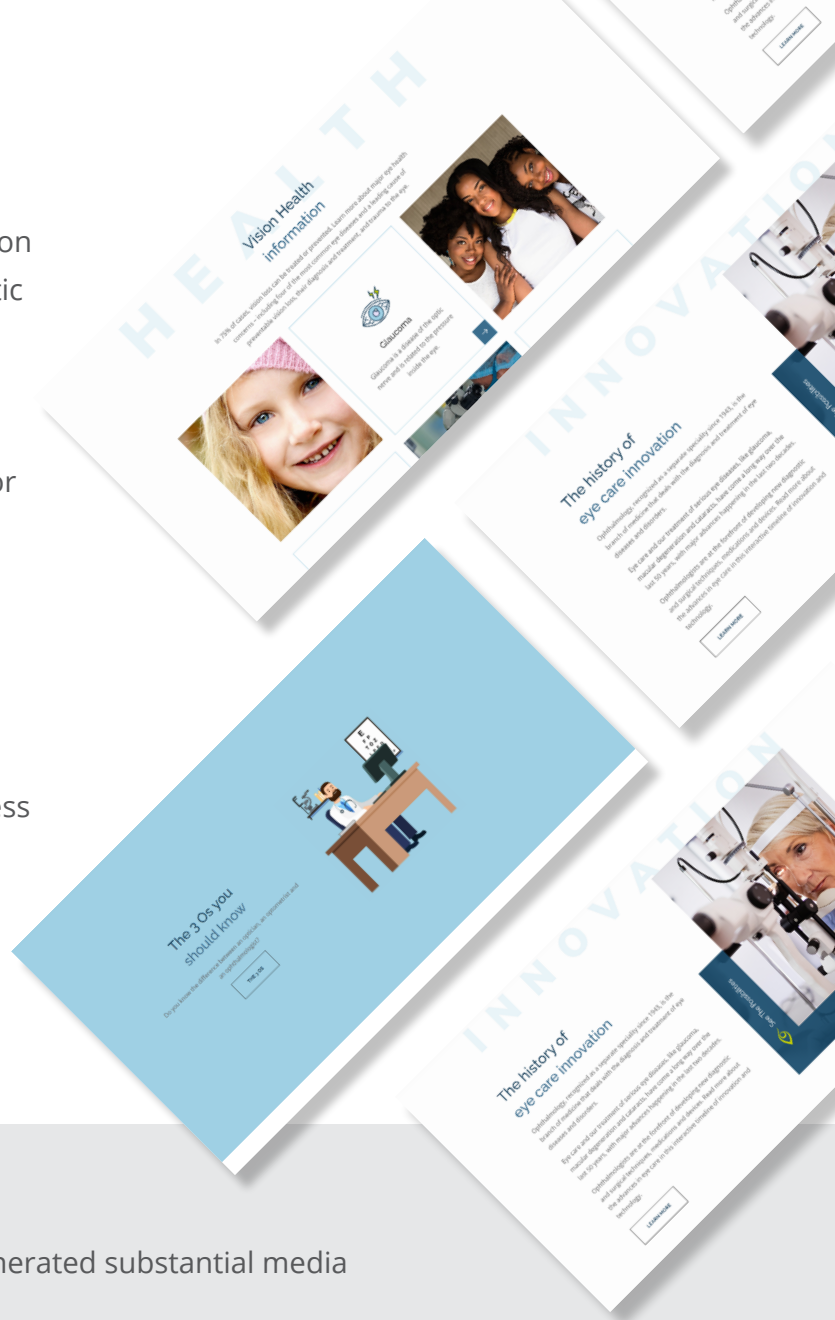
Engagement on the website increased by over 28%

#LoveYourEyes campaign: In recognition of World Sight Day (October 14, 2021), COS supported the International Agency for the Prevention of Blindness (IAPB) global #LoveYourEyes campaign – raising awareness in Canada and bringing a Canadian context to the message using the COS Leger survey results data. STRATEGIC RELATIONSHIPS

COS is relevant, innovative, and creative, and develops strong partnerships with other organizations to advance eye health. We support and empower our partners, encourage members to action, and engage and recognize our volunteers.

WORKING WITH OUR PARTNERS

COS continues to work closely with all our subspecialty societies, the provincial ophthalmology associations, and the academic community on major issues to position the expertise and skill of ophthalmology to government, the media, the public, and other medical and eye healthcare providers. COS's communications team has also redoubled its efforts to work with other partners to help highlight vision-related issues through cross-promotional campaigns.

OUTCOMES OF THE NATIONAL CONSENSUS FORUM ON IMPROVING CORNEA DONATION AND TRANSPLANTATION ACCESS IN CANADA

This collaboration with Canadian Blood Services resulted in several publications including:

“A National Consensus Forum on improving cornea donation and transplantation access in Canada” in *BMC Proceedings* (May 2021), and “Canadian demand and access to corneal transplantation: a provincial comparison” in *Cell and Tissue Banking* (November 2021). The next steps will be led by Dr. Darryl Lewis, Chair of the Implementation Committee.



REVIEW OF CMA DRIVER'S GUIDE

Every five years, CMA updates its Driver's Guide. CMA reached out to COS in August for our input. We sent out a request for volunteers to the membership and received a very strong response, with 11 members volunteering to participate. The Working Group held its first meeting in September and completed its review at the end of November. Thank you to the Working Group members: Dr. Selina Teja (Chair), Dr. Michael Henry, Dr. Danica Kindrachuk, Dr. Irfan Kherani, Dr. Jon Waisberg, Dr. Noa Mallek, Dr. Siddharth Nath, Dr. Harleen Bedi, Dr. Lulu Bursztyn, Dr. Salim Lahoud, and Dr. Hannah Chiu.

COST OF VISION LOSS AND BLINDNESS IN CANADA

COS actively participated in the update of the *Cost of Vision Loss and Blindness in Canada* report spearheaded by Fighting Blindness Canada and the Canadian Council for the Blind. The report was finalized and announced by press release on May 5, 2021 and reinforced through a webinar on the same day. Thanks to Dr. Colin Mann for his participation in the webinar during which he highlighted the work of ophthalmology in preventing blindness. The report estimates the total cost of preventable blindness to impact all Canadians at \$33 billion (direct health care costs – \$9.5 billion; indirect health care and other costs – \$6.1 billion; cost of well-being – \$17.4 billion). An *addendum* to the report that highlighted the impact of the COVID-19 pandemic was launched in October.

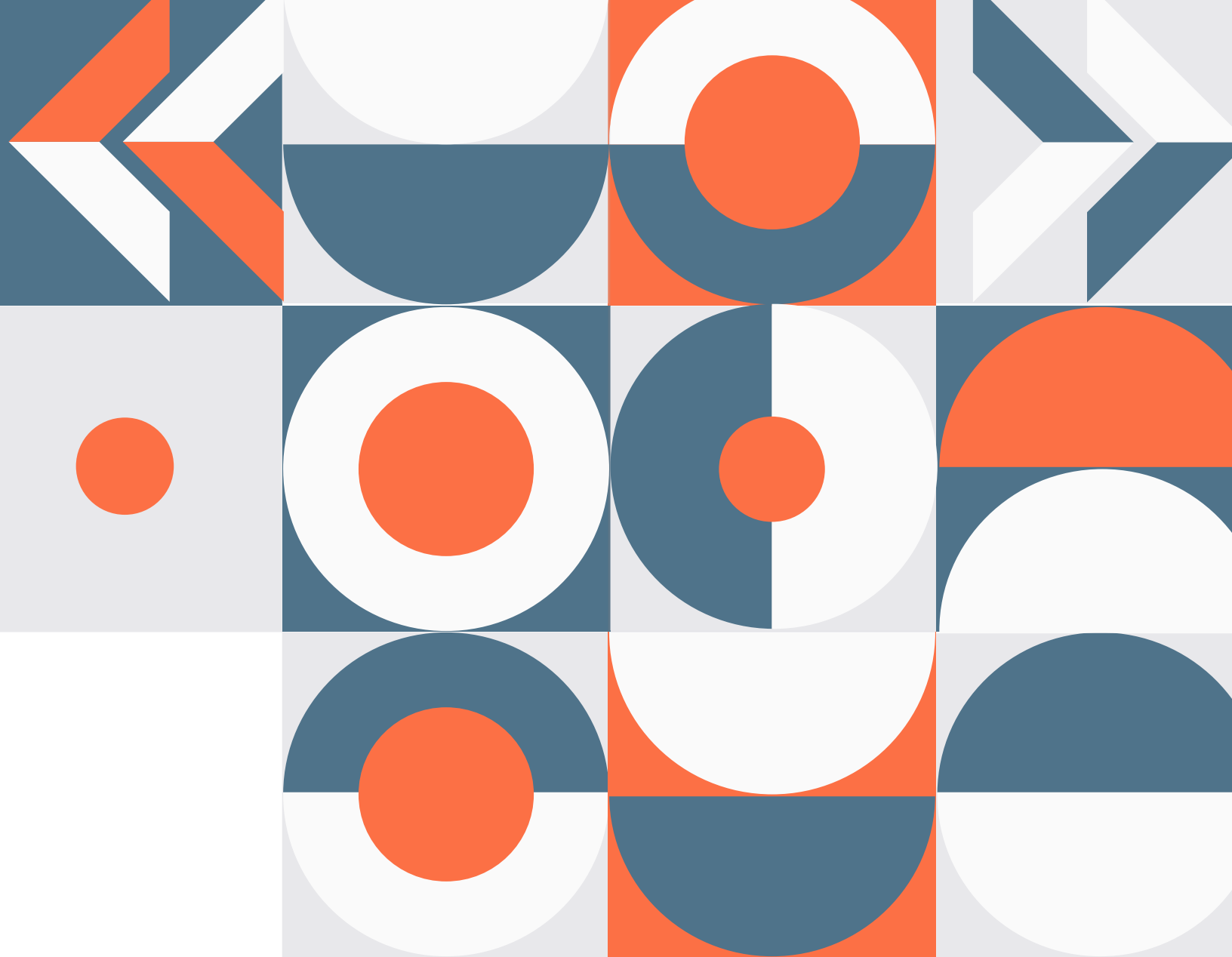
