Successful candidates must be eligible for licensure with the College of Physicians and Surgeons of Ontario and preference will be given to applicants who have specialty certification from the Royal College of Physicians & Surgeons of Canada (RCPSC) or the American Board of Specialties.

The Department has a busy glaucoma service providing all the complex glaucoma care for the region. The service is well equipped with all the latest diagnostic and therapeutic devices (MIGS, MIBS, tubes). The service is highly innovative and conducts research into new models of eye care delivery. It has a fellowship training program, training 1-2 fellows per year.

The Department also has an excellent residency program in Ophthalmology (with 12-13 residents). The Department enjoys an excellent reputation for employing innovative and enthusiastic teachers for learners at all levels. Preference will be given to applicants who have a strong track record or exhibit strong potential for clinical, surgical, and didactic teaching.
