



## **Oculoplastics Position - Department of Ophthalmology, The Ottawa Hospital**

The Ottawa Hospital (TOH) Department of Ophthalmology is seeking a fellowship trained Oculoplastics and Orbit specialist to join our dynamic team. The position would include all aspects of team-based patient care including surgical time, an academic appointment with the University of Ottawa, a prominent teaching role for residents and other trainees, and an appointment with the Ottawa Hospital Research Institute (OHRI).

We are seeking candidates interested in contributing to the research, academics, and administrative goals of the Department of Ophthalmology.

### **Primary Responsibilities:**

1. Provide primary Oculoplastics and Orbit care for the adult and pediatric population of Ottawa and surrounding areas.
2. Participate in the on-call rotation for The Ottawa Hospital
3. Train and supervise medical students, residents, fellows, colleagues, nurses, ophthalmic medical technologists and others as directed by the Department Head. Training expectations include teaching in the operating room, clinic, and didactic sessions.
4. Contribute to departmental initiatives by serving on committees, attending meetings, and undertaking administrative responsibilities as assigned.
5. Participate in the development and teaching of educational courses, or other presentations to internal and external groups.
6. Participate in complex cases requiring multi service co-operation with other departments (Otolaryngology, Neurosurgery).

### **Resources:**

- Access to TOH clinics
- Operating room resources at TOH based on current allocation methodology. Surgical time allocation is contingent on active teaching during allocated OR time and engagement in other departmental educational and administrative activities.

### **Basic Requirements:**

The successful candidate will have an MD or MD/PhD, have completed an accredited residency program in ophthalmology and have a minimum of 24 months of post-residency fellowship (ASOPRS preferred) training in Oculoplastics and Orbit (adult and pediatric).

**Additional Requirements:**

Applicants must:

- Be a Canadian citizen or hold landed immigrant status (preferred)
- Be licensed with the Royal College of Physicians and Surgeons of Ontario
- Have CMPA coverage.
