

**ACADEMIC OCULOPLASTIC AND ORBITAL SURGEON

The Department of Ophthalmology at Queen's University is seeking an Academic Oculoplastic and Orbital Surgeon. Qualified applicants will hold an MD degree with preference given to applicants with two years of sub-specialty training in oculoplastics and orbital surgery. Successful candidates **must** be eligible for licensure with the College of Physicians and Surgeons of Ontario and preference will be given to applicants who have specialty certification from the Royal College of Physicians & Surgeons of Canada (RCPSC) or the American Board of Specialties.

The successful incumbent will be expected to have a busy oculoplastic/orbital practice, performing a wide range of adult and pediatric orbital, lacrimal and eye lid surgeries. The position requires the successful candidate to share comprehensive ophthalmology city-wide on-call service with the remainder of the Department (approximately 4-6 weeks per year) and to be available to consult with the on-call team about oculoplastic patients. Participation in the urgent red eye clinic is also expected. All members of the department participate in teaching (medical school and post-graduate level), administrative work, and research commensurate with their job description defined annually with the department head.

Members of the Department of Ophthalmology enjoy a competitive compensation package, funded through an alternate funding plan (AFP). Academic rank will be commensurate with experience.

The Department also has an excellent residency program in Ophthalmology (with 12-13 residents). The Department enjoys an excellent reputation for employing innovative and enthusiastic teachers for learners at all levels. Preference will be given to applicants who have a strong track record or exhibit strong potential for clinical, surgical, and didactic teaching.

The Department is involved in new models of eye care delivery (including e-Consults, tele-ophthalmology, and remote real-time diagnostics). The Department has a strong research culture that is supported by an in-house research team. While this will be a busy clinical position, opportunities to collaborate in research exist for those who are highly motivated and interested in doing so.

Faculty and their dependents are eligible for an extensive benefits package including prescription drug coverage, vision care, dental care, long term disability insurance, life insurance and access to the Employee and Family Assistance Program. Employees also participate in a pension plan. Tuition assistance is available for qualifying employees,

their spouses and dependent children. Queen's values families and is pleased to provide a 'top up' to government parental leave benefits for eligible employees on maternity/parental leave. In addition, Queen's provides partial reimbursement for eligible daycare expenses for employees with dependent children in daycare.
