

This year, we were pleased to deliver unique and innovative professional development opportunities to members, including webinars, exciting updates to the Practice Resource Centre website, and an incredible in-person Annual Meeting & Exhibition in Halifax, Nova Scotia. Annual Meeting & Exhibition – June 9-12, 2022 Halifax, Nova Scotia

2022 marked our first in-person meeting in three years and the COS team and our many volunteers committed to delivering a program and exhibition that exceeded expectations. We were excited, to say the least!

From Away, Together Again was a fitting and inspiring theme as we overcame unprecedented challenges. The excitement was contagious at #COS2022, attracting an impressive 1,236 attendees, 18 Canadian and internationally renowned keynote speakers, 17 sponsors and 35 exhibitors, and state-of-the-art equipment and surgical materials.



Highlights of the meeting:

Scientific programming at its best

This year, the COS had many unique presentations and interactive sessions. COS 2022 included 2 co-developed symposia, 51 unique sessions featuring close to 300 speakers and an average attendance of 75 delegates per session. The meeting also offered up to 29.25 MOC Section 1 credit hours, 7.5 Section 2 credit hours and 12 Section 3 credit hours. In addition, we also had many new and in-demand STCs including:

- Technologies and Public and Global Eye Health Research to explore various modalities to reach remote communities and marginalized urban populations.
- Interactive STC on Social Eye Care: Meeting the Needs of the Vulnerable Populations in Canada.
- Yamane Double Needle Technique for Scleral IOL Fixation.

Our Resident's Symposia hosted eight speakers and offered an opportunity for young ophthalmologists to network and learn from each other as well as experts in the field. And the Women in Ophthalmology Symposium: How to Break the Glass Ceiling session showcased four inspiring keynote speakers, Dr. Irit Bahar, Dr. Patricia-Ann Laughrea, Dr. Andrea Molinari, and Dr. Carol Shields, who shared their vision with us and transformed us with their presence and energy.

Interactive co-developed accredited symposia:

The Lions' Lair: Retina Research Proposals judged three research presentations related to retinal disease. This program aimed to showcase and support the most innovative and impactful retina research proposals from young investigators in the field. The Lions' Lair was an opportunity for researchers to present their ideas and receive valuable feedback from a panel of experts, as well as the chance to compete for funding and support from Bayer to bring their proposals to life. This co-developed symposium by COS and Bayer highlights the commitment to advancing retina research and improving patient care.

Breaking News on Shaping the Future of AMD and DME, this co-developed symposium by COS and Roche hosted three international experts: Dr. Sunir Garg, Dr. Michael Ip, and Dr. Wai-Ching Lam and explored new surgical and non-surgical treatments for nAMD and DME, along with the top five signs not to miss in imaging.

Inaugural EDI Symposium

The Equity, Diversity and Inclusion Symposium focused on the impact of racism in medicine and healthcare, emerging research on gender equity in ophthalmology and how to integrate Indigenous health concepts into the provision of culturally sensitive care. We were honoured to have Dr. Marcia Anderson, Executive Director, Indigenous Academic Affairs, University of Manitoba deliver the keynote speech.





Lifetime Achievement Award - Dr. William Dixon

The COS was proud to honour the contributions of Dr. William Dixon by awarding him this year's Lifetime Achievement Award. Dr. Dixon is an Eye Bank specialist and leader within his field and the future of ophthalmic care and research. Through his involvement with the Department of Ophthalmology at the University of Toronto, CNIB, Eye Bank of Canada, Sunnybrook Health Sciences Centre, Orbis Canada, amongst others, Dr. Dixon has continued to maintain the highest standards of patient care and advance the practice and future of ophthalmology.

53rd Sally Letson Symposium

Adopting Innovation: Staying Ahead Without Falling Behind

The COS was pleased to support the SLS again this year. Almost 500 delegates attended the 53rd Sally Letson Symposium, September 8-10, 2022. Ophthalmologists and other vision health professionals learned from Canadian and international speakers on wide-ranging topics such as adapting innovation into practice in the field of ophthalmology. The program included high-yield sessions on cataract and refractive surgery planning and techniques, subspecialty pearls and updates, and general eye care topics.






Webinars in 2022

We were pleased to offer the following webinars:

- ***LGBTQ2S+ Issues in Ophthalmology*** – this webinar examined the status of health equity for LGBTQ2S+ patients and professional equity for LGBTQ2S+ ophthalmologists, with a view to creating safe spaces for and allyship with the LGBTQ2S+ community.
- ***What You Need to Know About Inherited Retinal Disease in the Age of Molecular Medicine*** – this webinar explained the importance of genetic testing and counseling for Inherited Retinal Dystrophies (IRD) patients and their families; effectively communicated the potential benefits of current and emerging gene therapies; and identified genetic testing and counseling resources in their respective regions and confidently refer patients accordingly.
- ***Topical Issues in nAMD Addressed by Retina Experts*** – this webinar discussed retinal fluid management and its impact on age-related macular degeneration (nAMD). Helping participants refine and optimize their nAMD management practices by recognizing therapy compliance issues and interpreting the significance of recalcitrant fluid and managing complications of anti-VEGF therapy and aimed to equip participants with the skills to identify common and less common complications and effectively manage nAMD, were two topics highlighted in this webinar. The overall goal was to help participants refine and optimize their nAMD management practices.
- ***Advancing Equity, Diversity, and Inclusion in Ophthalmology*** - Insights from Dr. Keith Carter discussed obvious inequities in society and healthcare and shared data showing the current state of healthcare disparities.



Advocacy



The COS Advocacy Council, under the leadership of Advocacy Chair Dr. Vivian Hill (Alberta), continued to meet and address issues of importance to the profession. With thanks to members of the Advocacy Council, and numerous ad hoc working groups, many new advocacy resources and initiatives were created and can be found in the members-only section of the COS website.

Drug Shortages remained an area of focus with unprecedented numbers of ophthalmic drugs going into shortage in 2022. COS drug shortages liaisons, Dr. Jamie Taylor and Dr. David Plemel, forged excellent relationships with Health Canada and industry partners to alleviate shortages and elevate some drugs to Tier 3 status.

The Provincial President's Council was launched in 2022 to help increase collaboration between provinces. The group plans to meet quarterly to discuss issues of importance in their provinces, to share information, and to discuss collaborative projects.




EyeCan: A Canadian Lens on Ophthalmology

COS Foundation Awards

Thanks to the generous support of the Raymond Stein Family, the COS Foundation has supported the Harold Stein Innovator Lectureship at the COS Annual Meeting and Exhibition since 2018. This lectureship award is given to a keynote speaker who has advanced innovation in ophthalmology.

In 2022, the Harold Stein Innovator Lecture was provided by Dr. Carol Shields on June 10, 2022. Dr. Shields' lecture focused on Conjunctival Tumors: From Surgery to Topicals to Biologics. 
