

Pediatric Ophthalmologist Specialist Position Department of Ophthalmology, CHEO, Ottawa, Ontario

The Department of Ophthalmology is seeking an ophthalmologist specialized in Pediatric Ophthalmology & Strabismus. The ideal candidate will hold RCPSC certification in Ophthalmology, a minimum one-year postgraduate fellowship in Pediatric Ophthalmology & Strabismus, and be eligible for full licensure with the College of Physicians & Surgeons of Ontario and CMPA coverage.

The successful candidate will have excellent interpersonal and teaching skills, and will thrive in a close-knit, inter-professional team environment. They will be committed to patient-centred care, continuous improvement and lifelong learning. Preference will be given to candidates interested in contributing to the academic and administrative goals of the Department and University.

Primary Responsibilities of a successful candidate:

- Tertiary level pediatric ophthalmology clinical care at CHEO
- Equitable participation in the general ophthalmology on-call rotation for The Ottawa Hospital and on-call clinic coverage.
- Commitment to Department, Hospital, and University support through an equitable contribution to clinical research, administrative duties, and teaching, including training and supervision of learners at all levels.

- An academic appointment with the University of Ottawa commensurate with experience and academic accomplishment

- For interested candidates with the appropriate skill set a partial adult cataract surgery allocation is possible at The Ottawa Hospital. This will require meeting departmental cataract teaching expectation.
